NETWORKING ACROSS BOUNDARIES AGAINST MARINE FRAUD

Hands-On In-Depth Training 3 November 2024

"Interview Training for Marine Investigators"



Richard Foreman retired as a Police officer with 30 years of service. He has been a career detective and has served on various major investigative teams, including homicide, fraud, and financial crime. He was also seconded to the UK's National Criminal Intelligence Service.

Richard has specialist knowledge of behavioral detection and credibility assessment interviewing. He is one of the UK's leading exponents in its use and operational deployment and is recognized nationally and internationally as an expert in this field.

Richard and his company, Profile Aware Limited, have been employed by UK government departments for 15 years to deliver behavioral detection and credibility assessment interviewing training. This training is offered to Law Enforcement, the Military, and the private sector in the UK and overseas.

The Credibility Assessment Interviewing (CAI) training is designed to enable students to elicit information from subjects and assess their credibility in various operational contexts such as interviews and de-briefing. The training combines practical tools and techniques based on robust scientific research and extensive operational experience. The training incorporates the latest thinking in detecting deception and represents the cutting-edge investigative and intelligence interviewing practice. The 1-day training input is comprised of the following key modules:

- Introduction to Credibility Assessment an overview of the course and the introduction of the tactic of educating information. The process involves obtaining actionable information, tangible evidence from subjects, and different interview session strategies.
- Cultural Attenuation a practical and robust method for working with subjects from different cultural backgrounds; an approach that helps the interviewer manage the interview more effectively and helps him/her assess the interviewee's credibility.
- Cues to Deception reliable cues to deception that have been scientifically validated and tested operationally.
- Principles of Detection practical approaches for reliable and accurate detection of deception.
- Pitching effective techniques and approaches for persuading a reluctant or obstructive subject to cooperate in the interview.
- **Elicitation** Introduction to elicitation and the techniques involved.
